By continuing with this registration, you agree, warrant and covenant as follows:

I certify and represent by my application for entry that my physical condition is adequate to compete safely in the event, and I hereby acknowledge that the above persons and entities have no obligation to provide medical care and have not undertaken the responsibility to do so. In the event I receive medical care as a result of a medical emergency, I hereby consent to such care and fully release the person(s) providing such care from any and all liability, whether resulting from negligence or otherwise. I authorize and consent to the publication, whether by videotape, film, newsprint, written advertisement or otherwise, of any materials containing my name or picture, and I release any sponsors and all persons acting under authority from any claims I might have due to initial or subsequent publication or use of any such materials or photographs. I hereby certify that I have fully read and understand the foregoing release, waiver and covenant not to sue and sign it knowingly, willingly and voluntarily.
